#### **Hope Partnership – Tax Relief Request**

HOPE Partnership is requesting tax relief from property taxes associated with some of their affordable unit properties. The Selectmen invited Tony Lyons, Karla Lindquist, and Jessica Sypher to the Selectmen's meeting this evening.

The Town has received a request to align the tax payment for HOPE Partnership to be like the Essex Housing Authority. The taxes paid by HOPE Partnership are already below 10%, which is what the Essex Housing Authority pays. The Town Assessor Jessica Sypher looked at Statutes for this type of request and this type of tax change would require a local ordinance and a contract between the Town and Hope Partnership.

Attorney David Royston mentioned that Old Saybrook affordable housing is a different situation. There are some units at 20%, 30%, and 40%. They want to be able to serve people in lower percentages, so that the rent, is based on their income, and the rent could be lowered. There was discussion of the Town considering a tax credit, which could be done by an ordinance. Under the state statute, it must be a non-profit that would get the tax credit. This credit would directly be helping residents.

Karla Linquist, Executive Director of HOPE Partnership stated that in Connecticut the abatements are done under this statute.

Attorney Royston mentioned there is another statute that could also be used – low moderate income – it would allow a town to give an exemption against the tax assessment.

Mr. Needleman requested HOPE Partnership provide the Town with a 1-year pro-forma budget for the following year.

The Selectmen requested that HOPE Partnership make a proposal to the Town that is uncomplicated and to be able to explain where any tax credit will be going and show that it is directly going towards affordable housing.

**Motion** was made by Norman Needleman to table this request until the next meeting. Stacia Libby seconded the motion, and it was unanimously approved. Motion carried.
