#### House number on mailboxes

There was discussion of possibly creating an ordinance to reinforce the rule of requiring a house or mailbox to be numbered or clearly marked so emergency services can find them when necessary.

#### Four (4) Year Term for Essex First Selectman

There was discussion of returning the First Selectman term to a four (4) year term starting in 2021.

## Town Clerk / Tax Collector

There was discussion of looking into converting the Town Clerk and Tax Collector positions from elected positions to appointed positions.

#### River Road Sidewalk

There was discussion that the River Road sidewalk project would be on the next grant application. The Selectmen would like to keep moving forward on this idea and they would also like to schedule a

meeting with the Town Planner to see if this project could be on the Council of Government transportation improvement list.

Mr. Needleman stated that he hopes that the State of Connecticut Office of Policy and Management will reinstate the Small Town Economic Assistant Program (STEAP). This grant allowed Towns to complete projects that they could never afford to do.

### Evans' Lane

This is pending and a court date has not been set.

## **Underground Power Lines**

There was discussion of installing underground power lines in and around Essex. It was determined that although not out of the question, it is very expensive to place power lines underground.
