Regular Meeting

Thursday, September 4, 2014 at 7:30 P.M.

The Essex Conservation Commission conducted the regular Meeting on September 4, 2014 in Room B of the Essex Town Hall.

Ms. Tucker called the meeting to order at 7:30 p.m.

Old Business

a. Trail Reports

Viney Hill Brook Park;

Trail Mowing, Japanese Knotweed, Broadwalk Drainage Pipes; Phragmite patches

Mr. Lovelace walked Viney Hill Brook Park today and he stated that the trails were all in good shape. Mr. Lovelace stated that earlier in the month Mr. Lovelace, his son Jeff and Mr. Helmecki cleared the drain pipe in the small pond that drains into Quarry Pond. The pipe was clogged with roots and other debris. Mr. Lovelace reported that since, the area has dried up to the point where the trail is passable on foot. Mr. Lovelace stated that the Commission received permission to perform this regulated activity which was granted by Joseph Budrow, Wetlands Enforcement Agent.

Mr. Lovelace stated that the Japanese Knotweed was sprayed on August 26, 2014 and he stated that the tree still looks very healthy. Mr. Lovelace stated that All Habitat Services was in the area of Broadwalk and the Blue trail today treating the area for tick control.

Mr. Lovelace stated that in the active recreation area there is a concrete pad on which a structure has been constructed. There will be a roof but no walls. Mr. Lovelace stated that maps are needed in the various stations.

Bushy Hill Preserve;

Schedule Trail Relocation or Pedestrian Footbridge Replacement

Ms. Tucker stated that All Habitat applied another mosquito treatment on August 8, 2014.

Ms. Tucker commented on the replacement of the pedestrian footbridges which are out of position. There was a discussion at the August meeting on the option to either reposition the bridges or the possibility of cutting a new trail.

Mr. Helmecki stated that the trail relocation has been accomplished. Mr. Helmecki stated that he started removing some of the debris which has piled up around one of the bridges.

Ms. Tucker stated that the Commission will revisit the condition of the footbridges at the October 2, 2014 Conservation Commission meeting.

Canfield Meadow Woods;

Schedule Tulip Tree Area Clean-Up

Ms. Forrest walked an area of Canfield Meadow Woods and she stated that the foot paths are clear. Ms. Forrest stated that there are plenty of maps remaining in the various stations.

Ms. Tucker asked members to meet one day on the last weekend of September for a clean-up of the underbrush so the structure of the Tulip tree would be more clearly visible. Members will email Ms. Tucker with their availability.

b. Discuss follow-up to request from Condominium Association for Vegetation Clearing

Mr. Lovelace stated that there has been no activity before the Inland Wetlands and Watercourses Commission related to the Middle Cove at Essex condominium for the mitigation of the phragmite.

Tamara Sutfin, President of the Middle Cove condo association presented before the Essex Conservation Commission at their August 7, 2014 meeting and indicated that the Association would benefit greatly from the support, input and assistance from the Conservation Commission.

Ms. Tucker reminded Mr. Lovelace that the Conservation Commission would like to coordinate with the Inland Wetland and Watercourses Commission and arrange for a site walk of this property.
