Minutes Regular Meeting Thursday, October 2, 2014 at 7:30 P.M. Town Hall, 29 West Avenue Second Floor Conference Room B

The Essex Conservation Commission conducted the regular Meeting on October 2, 2014 in Room B of the Essex Town Hall.

Ms. Tucker called the meeting to order at 7:32 p.m.

#### **Old Business**

a. Trail Reports

# Viney Hill Brook Park; Discuss Beaver Damage

Mr. Helmecki stated that there is a small tree located on the dam side of the Old Quarry pond in the area of the baffle that has been damaged by a Beaver.

Ms. Tucker contacted Joe Budrow, Essex Wetlands Enforcement Officer regarding the beaver damage. Mr. Lovelace will walk the area with Mr. Budrow to view the damage and discuss mitigation, in the upcoming weeks.

Ms. Tucker discussed several possible options for a solution for the area that encompasses the Viney Hill Preserve, noting that the pond cannot be allowed to be dammed up as the effects would negatively impact the trails and the property of the abutting neighbors.

# Update on Japanese Knotweed Treatments

Ms. Tucker stated that All Habitat applied a Polaris treatment to the Japanese Knotweed at Viney Hill Brook Park on September 26<sup>th</sup>.

Ms. Tucker commented on other solutions the Commission has applied toward the eradication of the Japanese Knotwood.

#### Other

Mr. Helmecki stated that he saw a growth of Autumn Olive in the area of the trail that meets the active swimming area.

# Bushy Hill Preserve; Approve Clean up of Cedar Meadow

Mr. Helmecki stated that he cleaned out the water diverters, removing the sediment and he also repositioned one of the diverters so that the water flow would not seep through and erode one of the trails.

Mr. Helmecki reported that Karl Kaufmann, Jr. volunteered his time to remove the fallen limb from the trail near the first small field. Mr. Kaufmann also trimmed the Cedars and Dogwood around the picnic tables. The trimmings will be dragged and neatly piled just beyond tree line to create brush pile habitat.

Mr. Helmecki noted that the meadow had been mowed.

Mr. Helmecki stated that some of the markers are missing from the trail.

The Essex Land Trust will facilitate a Bushy Hill hike on Saturday, October 4, 2014 at 9:00 a.m.

Ms. Forrest will obtain the name of the Canfield Meadow steward from Jim Denham. Ms. Forrest will notify the Canfield Meadow steward that Conservation Commission members will be cleaning up the underbrush in the area on Sunday, October 5, 2014.
