## a. Education/Training CIACW Conference

Ms. Tucker announced the CT Association of Conservation and Inland Wetlands and Watercourses 37<sup>th</sup> Annual meeting and Environmental Conference which will occur on November 15, 2014 in Wallingford, CT. The focus of this year's conference is "Preparing Connecticut for the Impact of Global Changes"

Mr. Lovelace expressed an interest in attending, however he was not sure of his schedule. Mr. Lovelace will contact Joseph Budrow, Land Use to confirm.

## b. Trail Reports

### Viney Hill Brook Park

Mr. Lovelace visited the Preserve on Wednesday. Mr. Lovelace put together a slide show of some of the issues he encountered on the trails and presented to the Commissioners. There is evidence of beaver activity in the area of Old Quarry Pond. The beavers have constructed a lodge which will eventually compromise the pond and further create a hazard to the recognized trail system and to the passive preserve. The CT General State Statutes recommend beaver remediation by entrapment. Members discussed remediation. Photos of the damaged areas affected by the beaver activity are attached and made a part of the Minutes.

Mr. Lovelace displayed slides of the area in which the Japanese Knotweed is located and the areas that have been treated by All Habitat. Ms. Tucker will check with All Habitat and inquire about the eradication of the remainder of the Japanese Knotwood.

Mr. Lovelace stated that he cleaned-up trash on some of the trails.

**MOTION** made by J. Lovelace to engage a State licensed trapper whose services the Commission previously utilized, to entrap the beavers, at no charge to the Town; **SECONDED** by R. Ms. Bernardini presented a bill for \$225 for trail mowing from Windmillhillfarm. Ms. Tucker will authorize the payment of this invoice.

### Bushy Hill Preserve

Mr. Helmecki stated that the slats in the footbridge will need to be replaced. Mr. Helmecki will pick up the boards and contact Ms. Tucker who will assist with the repair. Mr. Helmecki will contact Ms. Tucker when he has picked up the boards to schedule time to meet.

# • Canfield Meadow Woods Tulip Tree Area Clean-up

Kay Tucker, Adrienne Forrest and Rich Helmecki cleaned up around the large Tulip tree and removed debris and smaller branches. The area is in good shape.
