#### b. Trail Reports:

**Report from Viney Hill Brook Park Work Party** 

R Helmecki reported that he was at Viney Hill Brook Park on April 18<sup>th</sup> and he cut down and cleaned up an area and treated the Autumn Olive stumps with Roundup.

## **Current Conditions at Viney Hill Brook Park**

F Hall stated that he walked around Quarry Pond, checked exclusion fences and the water was flowing. F Hall noted that the walkway to the west of the Scout Bridge was dry. There is a small branch on east side of the trail that needs to be cut.

M Reeves will draft a sketch of cross-section of French drain, etc., for intersection of Broadwalk and Quarry Pond trails and present at the June 14<sup>th</sup> Conservation Commission meeting. Members will review and the plan which will then go to Bob Doane, P.E. for final review prior to presentation to the Essex IWWC.

#### **Canfield Meadow Woods**

Jim O'Brien visited Canfield Meadow Woods and he reported that he walked the Orange trail and noted that the trails are in good condition and there is no major work to be done at this time.

## **Bushy Hill Preserve**

R Helmecki reported that he walked Bushy Hill Preserve and noted that the trails look good.

R Helmecki stated that Clark's Custom Services conducted the second cutting of the big field, however they did not cut all the way back.

## c. Update from Beaver Solutions

F Hall reported that he had an email (Add- conversation) with Mike Callahan, Beaver Solutions and M Callahan will be in Essex on May 17<sup>th,</sup> scheduled to arrive between 2-3:00 p.m. to inspect exclusion fences and pond leveler pipes at Quarry Pond and off of Cedar Terrace ext.

A Forrest reported that All Habitat will inspect and apply larvicide treatment for mosquitos in bushy Hill Preserve next week. Also, chemical control of Phragmites and Knotweed with permitting will occur in Viney Hill Brook Preserve.
