Approval of Minutes

Motion was made by Anthony Mosa to accept the minutes from the June 6, 2012 regular meeting. Doug Senn seconded the motion and it was unanimously approved. Motion carried.

Financial Updates

Financial Reports were reviewed by Rick Audet. There were four reports presented at the meeting: 2011/2012 Fiscal Year End General Fund Budget, 2011/2012 Fiscal Year End Special Revenue Budget, Current General Fund Budget as of 8/31/12, Current Special Revenue Budget as of 8/31/2012. In the 2011/2012 Fiscal Year End General Fund Budget, it was noted that the overage was caused by expenses incurred after Tropical Storm Irene the past year as well as a \$920.83 water bill received on June 18. There was discussion as to how the Department can better track its water use and keep its usage and costs down. It was noted that we water the parks more in July and August and we had new trees planted at Hubbard Park that required more watering as well. It was suggested that the Department can contact CT Water and sit through a water accounts audit with them. On the 2011/2012 Fiscal Year End Special Revenue Budget, net revenue for each program was shown as well as the final fund balance in special revenue for the year.

Motion was made by Doug Senn to accept the financial statements as presented. Jim Rawn seconded the motion and it was unanimously approved. Motion carried.

B. 2013 Viney Hill Brook Park Lifeguards – Rick Audet shared an email from CIRMA regarding the potential elimination of the life guards. Mr. Audet summarized the email by stating that there are no current legal requirements to require a town to provide lifeguards as long as there is sufficient signage. However if swimming is permitted water testing must be done. The Commission took this information and will discuss possible changes to the life guard schedule at the next commission meeting.
