STEAP Grant

Mr. Lee Thompson reported on a STEAP Grant Program opportunity for fiscal year 2012. The award could be up to \$500,000. Mr. Thompson discussed the application proposal involving the purchase of a trolley that would help with transportation for tourists during the summer months and would also provide transportation for seniors. The trolley would be run by the Estuary Transit. Mr. Thompson stated that the trolley will cost around \$160,000.

The grant award funds would pay for the trolley, signage, storage of the trolley, and three years contingency for operating expenses. The trolley would most likely be operational from Memorial Day to Labor Day.
