

- Waxes and polishes
- Brake fluid
- Rust preventatives

- Wood preservatives
- Wood strippers
- Oil-based paint
- Latex paint
- Lead-based paint
- Paint thinner
- Degreasers
- Solvents

- **Explosives, fireworks, ammunition** – State Police, local marinas
- **BBQ Propane tanks**–Deep River RentAll
- **Fire extinguishers** – Shoreline Fire Extinguishers, Old Saybrook
- **Empty aerosol cans**–dispose in the garbage
- **Drugs**– dispose in trash
- **Bottled Gas**– Airgas, Waterford
