


**TOWN OF ESSEX

**TO ACT AND CONSIDER THE FOLLOWING:**

1. To accept the Statement of Town Accounts, report of the Town Treasurer and the report of the Superintendent of Schools, as printed in the 2022-2023 Annual Town Report.
2. To consent and approve of the appointment by the First Selectman of three (3) regular members to the Conservation Commission.
3. To consent and approve of the appointment by the First Selectman of one (1) alternate member to the Conservation Commission.
4. To consent and approve of the appointment by the First Selectman of three (3) regular members to the Economic Development Commission.
5. To consent and approve of the appointment by the Board of Selectmen of one (1) regular member to the Harbor Management Commission.
6. To consent and approve of the appointment by the Board of Selectmen of one (1) alternate member to the Harbor Management Commission.
7. To consent and approve of the appointment by the First Selectman of two (2) regular members to the Inland Wetlands and Watercourses Commission.
8. To consent and approve of the appointment by the Board of Selectmen of three (3) regular members to the Park and Recreation Commission.

15. To consent and approve an appropriation of a sum not to exceed \$150,000 from the Fire Department Sinking Fund to refurbish the 1994 Pierce Engine 652.
16. To consent and approve an additional appropriation in an amount not to exceed \$35,000 to be allocated from the American Rescue Plan Act (ARPA) Funds to cover the shortfall on the new ambulance.
17. To consent and approve an additional appropriation in an amount not to exceed \$50,000.00 to be allocated from the American Rescue Plan Act (ARPA) Funds to the Public Works Department for additional tree work.
