OLD BUSINESS

Facilities/Wastewater Management Plan – Lisa Fasulo

Ms. Malan discussed possible USDA loans available for a Facilities Management Plan.

REPORT – DAVID CAROLINE, PUBLIC WORKS DIRECTOR

Mr. Caroline was not present.

<u>REPORT – LISA FASULO, HEALTH DIRECTOR</u>

Ms. Fasulo received the bill for the water monitoring for nine sites. This will be reviewed before payment. This testing is for pollutants. This also includes two surface water tests done at the Transfer Station.

REVIEW OPERATING STATEMENT AND INCOME STATEMENT

The Authority reviewed the reports. Coding is still not accurate. Ms. Malan would like coding to be corrected by the end of the year.

NEW BUSINESS

Vacation Rental Properties

Ms. Malan discussed regulations on vacation properties. These properties are heavily used during the summer months and potentially by many more occupants than would be in a typical residential dwelling; and then not used as much at other times of the year. Ms. Malan feels we need to have something in place for these properties to monitor peak usage for possible septic issues/failures. Mr. Reeves and Mr. Bombaci feel that this should not be addressed at this time. Mr. Reeves noted that this is a zoning issue.
