#### **OLD BUSINESS:**

#### Capital Committee:

Mr. Glowac reported that the Capital Committee met with Mary Ellen Barnes, Park & Rec Director, on October 25th to discuss the Park & Recreation capital improvements wish list. The list included, among other things, a new recreation center, a pool, and pickleball courts. The Essex Elementary School was the original suggested venue for the pickleball courts, but Ms. Barnes was opposed to this location because there would be limited use based on the school hours, the Park & Rec camp being at the school in the summer, and it would be very noisy for the residents in the area. Mr. Glowac said the committee discussed Viney Hill Brook Park as being a viable location. General discussion ensued about the current usage of Viney Hill Brook Park and the maintenance of the gate to the park. Mr. Needleman would like further research to be done regarding the use of the land.

Mr. Needleman met with Region 4 leadership to review capital projects and the Town's Average Daily Membership (ADM). The Essex ADM % went down slightly. The Board of Education hired a consultant to review long-term capital needs and presented a list of improvements estimated to cost \$16M for Region 4.
