## **Comcast Fiber Quote**

The Town received a quote from Comcast to run and operate a dedicated fiber from the PSDN from the Essex Fire Station up to Grandview Terrace. This project relates to public safety for Essex and the region. There is an initial upfront cost and there will be monthly charges. The initial upfront cost is \$18,100. Valley Shore Emergency Communications will pay for the monthly charges.

**Motion** was made by Bruce Glowac to approve and recommend to the Board of Finance an appropriation from the unassigned fund in the amount of \$18,100 to the Essex Fire Department to cover the upfront costs to run and operate a dedicated Ethernet Private Fiber Line.
