#### **SELECTMEN GENERAL DISCUSSION:**

The Board of Selectmen were approached with a request to look at the possibility of burying all utility lines. Town Engineer Bob Doane and Town Planner John Guszkowski have been asked to determine what the costs would be to bury all utilities underground.

Mr. Needleman also suggested the Town do a study on onsite community septic systems and to possibly obtain estimates for a future project.

The Selectmen were discussing the Dickinson House and the potential for such a home to become a bed and breakfast, but unfortunately, the Town of Essex does not allow bed and breakfasts. There was discussion that the house would be perfect for a bed and breakfast and currently only events such as weddings or gathering for up to 75 people are happening there.

**Motion** was made by Norman Needleman to adjourn the meeting at 7:59 p.m. Bruce Glowac seconded the motion, it was unanimously approved. Motion carried.
