## **Approval of Agenda:**

**Motion** was made by Norman Needleman to approve the Agenda with the following additions. Under New Business add Eversource – Street Lights. # <u>Informational Items, Communications and Correspondence:</u>

#### Thank You Letters

The First Selectman received a letter of thanks for the helpfulness of the Land Use Department with the permitting process. Another letter of thanks came for the Public Works Crew on a job well done with the weekend snow storm and the clearing of the roads.

## UConn's Community Research / Design Collaborative - Potential Essex Project

There was discussion regarding a project where students from UConn would spend a few weeks visiting the area to come up with proposed design concepts.

#### **OLD BUSINESS:**

#### **Capital Committee**

Mr. Glowac reported they are still working on the design plans for the land use offices at Town Hall. The library renovation budget is coming in higher than expected because the remediation costs are coming in higher.

#### <u>Essex Housing Authority – Essex Place – Development Documents</u>

No documents are being presented for approval this evening. This item has been tabled to the February 17, 2016 Board of Selectmen Meeting.

#### **Police Assistance Agreement**

There was discussion on the Police Assistance Agreement. Mr. Needleman stated the intent of the agreement is to provide private duty coverage when there are a lot of events in Town.

**Motion** was made by Stacia Libby to approve the Police Assistance Agreement. Stacia Libby seconded the motion. All in favor.

#### **NEW BUSINESS:**

## **Eversource – Street Lights**

There was discussion on the possibility of replacing the street light fixtures with LED bulbs. The Selectmen are not in favor of owning the street lights. There was discussion regarding the color of the lighting. The Selectmen will take a look at the color of lights in other Towns. This was tabled until the next Selectmen's meeting.

### **Capital Lease Pumpout Boat Down Payment**

There was discussion on the Pumpout Boat Program. The Town does not pay for the operation of the Pumpout Boat Program, but the Town administers the grant that pays for the program. The program needs a new Pumpout boat and the Town went out to bid for a new boat. Marine Boat Builders was the lowest responsible bidder. There was discussion on the process of acquiring the boat and the steps needed to finance the boat. There was discussion on providing a short-term down payment of approximately 50% down for 90 days for the Town's new Pumpout Boat. Once the capital lease financing is in place, the deposit will be returned back to the Town.

**Motion** was made by Stacia Libby to approve paying the deposit for the down payment for the Pumpout boat for the 90 day period. Once the capital lease financing is in place, the deposit will be returned back to the town. Bruce Glowac seconded the motion, it was unanimously approved. Motion carried.

## **Appointments and Resignations Board and Commissions**

There was discussion that Zoning Commission and Zoning Board of Appeals unexpired terms are filled by the commission with alternates currently serving on the Board; typically vacancies are filled with the longest standing alternate member. Unfilled terms are filled by the First Selectman or Board of Selectmen.
