Approval of Agenda:

Informational Items, Communications and Correspondence:

Board and Commission Vacancies

There was discussion on current vacant positions on Town Boards and Commissions. There is one vacancy on Conservation Commission, one on Inland Wetlands Commission, one on the Retirement Board, and there are three vacancies on the Park and Recreation Commission.

Director of Tri-Town Youth Services Position

It was recently reported to the Essex Selectman that the Director of Tri-Town Youth Services was retiring and a new Director was chosen for the position. Several calls came into the Selectman's office inquiring if the Town knew when the Director position would be posted and when the hiring or application period would begin. The Selectmen felt that since surrounding Towns work closely with Tri Town and contribute substantial funds to Tri-Town, they should have been notified of the vacancy and had some input in the hiring of the new Director.

Public Announcements / Comment:

There was discussion of the financial impact due to the funding cuts from the State of Connecticut to Municipalities.

The railing for the Ivory Street Bridge is anticipated to arrive within the next three (3) weeks.

OLD BUSINESS:

Capital Building Committee

Mr. Glowac reported that Riggio Construction is continuing to work on shoring up the floor joists over the Town Hall auditorium. There were findings of significant cracking of the joists that could potentially have become unsafe if left unrepaired. Once the ceiling is deemed safe, the filing cabinets will be scheduled and installed in the Land Use Department on the second floor. The auditorium ceiling insulation and lighting installation is also being scheduled.
