# Open Space Sinking Fund Request - Essex Land Trust

The Essex Land Trust ("ELT") is working on a project to acquire land Mblu 06 007 known as the Doane Property (18.4 acres) that will create a new corridor by connecting James Glen (3.5 acres) and Doanes' Woods Preserve (17.24 acres), with the Deep River Land Trust Lyons Meadow Property (10.7 acres), for a total of 50 acres.

The Doane Property purchase cost is anticipated to be \$241,150 (65% of Fair Market Value, \$371,000). Funding for the purchase is expected to come from different sources:

- 1. Department of Energy and Environment Protection for the Open Space and Watershed Land Acquisition Grant, contingent on being awarded.
- 2. The Essex Land Trust's own funds in the bank
- 3. Fundraising efforts in the spring
- 4. An existing line of credit with Essex Savings Bank

**Motion** was made by Bruce Glowac to approve and recommend to the Board of Finance the appropriation of a sum not to exceed \$50,000.00 as partial funding for the purchase of Mblu 06 007 known as the Doane Property (18.4 +/- acres) of land off Oxbow Lane in Essex. Said sum to be taken from the Open Space Sinking Fund. Stacia Libby seconded the motion and it was unanimously approved. Motion carried.
