Sinking Fund Request – Essex Fire Department Tower #1 Proposed Upgrades and Refurbishment
Members of the Essex Fire Department presented to the Board of Selectmen an upgrade proposal for
Truck 671, a 1994 Sutphen SP100 Arial Platform which was purchased, repainted and upgraded in 2009.
The truck is 24 years old. The service life of a piece of equipment is typically 20 years and this equipment is 24 years of age. The Selectmen felt the quote for the upgrades was more than reasonable.

Motion was made by Norman Needleman to approve and recommend to the Board of Finance the appropriation of a sum not to exceed \$165,000.00 for the upgrades and refurbishment of the Tower #1 Fire Apparatus. Said sum to be taken from the Fire Department Sinking Fund. Bruce Glowac seconded the motion and it was unanimously approved. Motion carried.

Essex Fire Engine Company, No. 1 - Proposed 10 Year Capital Expenditures Plan

Chief Aron Schumacher presented to the Board of Selectmen a proposed ten (10) year capital expenditures plan. Some items on the proposed plan are an acquisition of a fire boat, upgrades to radios, new self-contained breathing firefighter (SCBA) equipment, and upgrades to the Ivoryton Fire House. The selectmen thanked the Fire Department for the proposals and requested that the fire department submit to the Selectmen a table or a chart with estimates and/or numbers for the proposals.

<u>Supplemental Appropriation – Tree Removal</u>

Due to the gypsy moth devastation to trees and drought, there are several large dead Town trees that are unsafe and must be removed.

Motion was made by Norman Needleman to approve and recommend to the Board of Finance a supplemental appropriation of a sum not to exceed \$25,000.00 to the Highway Department Grounds Maintenance & Repair budget for tree removal. Bruce Glowac seconded the motion and it was unanimously approved. Motion carried.

Investigation of Parking Expansion in Ivoryton

The Selectmen received a memo from the Planning Commission with parking expansion proposals for Ivoryton. The commission is seeking a solution or improvements to parking availability. The Selectmen thanked the Planning Commission for their suggestions and they will visit the Ivoryton area to determine whether some of the ideas mentioned in the memo are feasible. The Town currently does not have any plan for parking improvements in Ivoryton, but they are investigating options.
