Resolution Declaring The Essex Elementary School Renovation And Addition Project Complete And De-Authorizing The Remaining Authorized And Unissued Appropriation And Bond Authorization.

Whereas the Town of Essex on May 17, 2005 authorized an appropriation and bond issuance authorization of \$10,130,000 for the renovation and expansion of Essex Elementary School, and on May 2, 20017 increased the appropriation and bond authorization to \$13,300,000 (the "Project");

Whereas the Project has been constructed, is complete and no further work on the Project pursuant to the appropriation and bond authorization is required;

Whereas the State of Connecticut has completed its audit of the project and determined the final grant payments pursuant to the State's school construction grant program;

Whereas the Essex Board of Education has accepted and closed the project;

Whereas there remains an authorized and unissued balance of \$237,291 of appropriation and bond authorization which is not required for the Project;

Now Therefore,

The Board of Selectmen find and determine that the Project is compete, no further expenditures are required or to be permitted from the appropriation and no further bonds are required or to be permitted to be issued pursuant to the bond authorization, and that the authorized and unissued balance of the appropriation and bond authorization is hereby de-authorized.
