Mr. Seidman discussed that the village of Centerbrook is the focus of a Main Street Initiative grant. Ms. Heiser noted that she is unclear how the selection process occurred. Mr. Cook stated that all villages have issues that could be considered. Mr. Seidman will discuss this further with Ms. Malan and First Selectman Needleman. It was also discussed that better signage in Centerbrook would be beneficial and that additional planning for better living needs to be considered for Centerbrook.
