# ESSEX PARK AND RECREATION COMMISSION MINUTES April 2, 2014

#### (Please note these minutes have yet to be approved)

Bob Russo called the meeting to order at 7:05pm.

Members Present: Tony Mosa, Bob Russo, Ginny Willets, Cathy Bishop, Peter Sarner, John Bauman

Park and Recreation Director Rick Audet and Recreation Program Manager Mary Ellen Barnes were also present, along with First Selectman Norm Needleman

#### **Approval of Minutes**

Motion was made by Tony Mosa to accept the March 5, 2014 regular meeting minutes as presented. Ginny Willetts seconded the motion and it was unanimously approved. Motion carried

Motion was made by Cathy Bishop to accept the March 17 Special Meeting minutes as presented. Tony Mosa seconded the motion and a discussion followed, the approval of minutes for the March 17, 2014 Special Meeting was tabled, and Cathy Bishop withdrew the motion to accept the minutes as presented.

Motion was made by Tony Mosa to amend the agenda as presented, Peter Sarner seconded the motion and it was unanimously approved.

#### **Old Business**

## Civic Campus STEAP Grant: Grove Street Park Playground & Tennis Court

Bob Russo stated that he and Tony Mosa had hoped to meet with First Selectman Norm Needleman to discuss requesting additional funding for the Tennis Court Project but he was unavailable so they decided to invite Mr. Needleman to our regular commission meeting. The discussion centered on if project contingency funds are available to improve the lighting, pay for the concrete border of the courts. Per Norm Needleman no contingency funds are available to add anything not in the original plans to the tennis court project. Lights were not part of the originally planned project. Surfacing and fencing were the primary objectives of the project, the fencing having been decided upon after the project started. Mr. Needleman thanked the Bauman Foundation for their generous gift to enhance the tennis court project. John Bauman stated that he was very excited about the improvements to the tennis courts and wanted to know what he could do to add to the project. He didn't know that improving the lighting was not included in the original project plans. He stated that the lights are substandard and that improvements are needed. Rick Audet stated that the light bulbs were replaced and lenses cleaned in 2011/2012. John Bauman stated that he believed that 100,000.00 dollars was appropriated for the tennis court and the town has spent 77,000.00 dollars. Norm Needleman stated that without the grant the Tennis court and the Play-scape would not have been redone, and the process of allocating the money was a work in progress and was reviewed to get the most done with the budget they had. The Park and Recreation component was approximately \$200,000 to \$250,000 dollars, and the fencing was an unexpected expense. John Bauman stated that if you are going to do a tennis court fencing should have been in the original plan. John Bauman believes that the Bauman Foundation gift should be held for future tennis court improvements and should not utility the gift for improving curbing. Bob Russo agrees lights are substandard and that the commission should

exam the costs to improve the lighting. Norm Needleman stated his is a strong advocate for increasing the Park and Recreation Sinking Funds because it is important that we maintain our assets. Mr. Bauman agrees stated that the play-scape and the Tennis court are economic enhancements to our community. Cathy Bishop is concerned that we would completely deplete our sinking funds if we replace the lighting and although she supports getting lighted doesn't mean we need them now. Proposes getting 2 solid estimates, Bob agrees that the commission should do research about costs. Tony Mosa stated that a decision on lighting doesn't affect the present plans of tennis court project. John Bauman volunteered to research improving existing lighting and costs associated with new lighting. Ginny Willetts believes that we need to ensure that the fencing and surfacing are in top condition, and Norm discussed the planning in regards to the paving of the asphalt for the courts.

John Bauman & Norm Needleman left meeting at approximately 8pm.
