Approval of Agenda:

- 15. Art reviewed his recommendations for the current portfolio as well as the new proposed portfolio, which include a total of 7 new funds.

- c. Kelly submitted an invoice for payment to Hooker & Holcombe for preparing financial reporting disclosures. Per our records, the charge for the GASB 67 & 68 Pension reporting disclosures in 2017 was \$2,500.00 versus the current year charge of \$2,600.00. Next year will be the OPEB disclosure.

Ethan Goller moved to initiate the payment to H&H in the amount of \$2,600.00 for the GASB 67 & 68 Pension reporting, seconded by Stacia Libby. Passed. Motion carried.

e. Police Plan Amendment 4 – Kelly distributed the rewritten Participant Contributions to the Amendment No. 4 to the Town of Essex Police Retirement Plan. Section 4.2 would change and Section 4.3b would change. Should we recommend these changes it would need to go to the Board of Selectmen and then go to a Town Meeting.

Ellen Whaley-Wexler made a motion to approve Amendment No. 4 to the Town of Essex Police Retirement Plan effective July 1, pursuant to Section 12 of the plan as reviewed in section. Peter Decker moved to accept the motion seconded by Stacia Libby and move back to the Town. Passed. Motion carried.

Kelly Sterner mentioned that our 3-year contract with H&H is just about up. Ellen Whaley-Wexler indicated we need to think this through and discuss whether we should move forward with them or revisit the bid process. She will propose this to the ERB in January 2020 and be open for discussion at our next meeting.

A request to cancel the December 10, 2019 meeting was discussed.

Motion made by Ellen Whaley-Wexler to cancel the December 10th, 2019 meeting, seconded by Stacia Libby. Passed. Motion carried.
