OLD BUSINESS:

Emergency Operations Center Refit

Mr. Needleman reported that our insurance company would allow for cleaning up of the mold in the basement, not the asbestos. They would also pay for the moving of the Emergency Operations Center (EOC) from the basement up one floor and then they would move ECO back downstairs. The process will be complicated and we are getting the appropriate quotes. We want to eliminate the water problems downstairs, especially in the vault. The vault is lower and the insurance company stated they would not pay for the

vault remediation, but Mr. Needleman stated that while we were fixing the water problem in the EOC room we should also address the vault at the same time.

NEW BUSINESS:

Set Public Hearing and Town Meeting

Mr. Needleman reported on the short list of Emergency Management items that had been recommended by the Board of Selectmen to be purchased this fall either from contingency or by an appropriation in order to set the town up in preparation of a severe storm this winter.

Emergency Management Suggested Improvements:

Mr. Needleman reported that in follow-up to Tropical Storm Irene Emergency Management put together a list of improvements and needs. The initial list totaled \$223,349.17. The list has been reviewed and pared down to \$32,528. The list has been reduced quite a bit and the Selectmen fully support the volunteers having equipment in working order. Items on the list include signage to be used for Centerbrook and Ivoryton, a hydraulic thumb, first responder radios and repeaters, emergency management flyer project, email spooler and transportable sandwich boards.

Motion was made by Norman Needleman to set a public hearing on Wednesday, December 7th at 7 p.m. for the purpose of going over the list of items that were found lacking after Tropical Storm Irene. Joel Marzi seconded the motion and it was unanimously approved. Motion carried.

Motion was made by Norman Needleman to set a Special Town Meeting on Wednesday, December 21, 2011 at 6:30 p.m. Joel Marzi seconded the motion and it was unanimously approved. Motion carried.

Mr. Marzi did some research on agendas and public comment. He found that although you should limit discussion to items on the agenda, you should always allow people to speak or comment on what people want to speak about. Mr. Marzi stated that the Selectmen could set rules on how to handle non-productive comments. It is the only time the public can interface the Board of Selectmen. He also wanted to address setting some rules on how to compile the agenda.

Mr. Needleman felt that the Selectmen have always been very flexible in allowing participation from the public at the Selectmen meetings.

Mr. Needleman stated that if the public comment is at the end of the meeting and someone is present that just wants to make an announcement, then they have to wait until the end

of the meeting. Mr. Needleman stated that the public is always welcome to be here, it is a public forum.

Mr. Marzi stated the Board of Selectmen is held at a higher standard. There was discussion regarding whether public comment is even a requirement at a Board of Selectmen meeting.

Mr. Marzi stated that he would do a little bit more research on the public comment section and would like to keep an open government with open communication and to leave the agenda the way it was.

Motion was made by Norman Needleman to adjourn the regular meeting at 7:26 p.m. Norman Needleman seconded the motion and it was unanimously approved. Motion carried.
