NOTICE IS HEREBY GIVEN that a Special Town Meeting will be held in and for the Town of Essex, Connecticut, Wednesday, July 21, 2021 at 4:30 pm in the Essex Town Hall, West Avenue in said Essex.

TO ACT AND CONSIDER THE FOLLOWING:

1. To consent and approve the acceptance of the American Rescue Plan Act Funds as recommended and approved by the Board of Finance.
2. To consent and approve an appropriation in an amount not to exceed \$35,000 to be allocated from the American Rescue Plan Act Funds (ARPA) for the Fire Department for the coaching, training, team building and counseling due to the impact of the Covid pandemic.
3. To consent and approve an appropriation in an amount not to exceed \$25,000 to be allocated from the American Rescue Plan Act (ARPA) for the installation and grounding of new antennas on the Essex Town Hall building. ~~If ARPA Funds are deemed ineligible, an appropriation from the Municipal Property Sinking Funds will be utilized.~~
4. ~~To consent and approve an appropriation in an amount not to exceed \$25,000 to be allocated from Municipal Property Sinking Fund, contingent upon non-eligibility of ARPA Funds, for the installation and grounding of new antennas on the Essex Town Hall building.~~
5. To consent and approve an appropriation in an amount not to exceed \$75,000 from the American Rescue Plan Act (ARPA) Funds for the purchase of a 2021 Ford Utility Interceptor vehicle and all necessary computer, radio and lighting equipment. If ARPA Funds are deemed ineligible, an appropriation from the Police Vehicle Sinking Funds will be utilized.
6. To consent and approve an appropriation in an amount not to exceed \$10,000 from the Police Vehicle Sinking Fund, contingent upon non-eligibility of ARPA Funds, for the purchase of a new police vehicle and all necessary equipment as recommended and approved by the Board of Finance.
