**TO ACT AND CONSIDER THE FOLLOWING:**


1. To consent and approve a supplemental appropriation to the 2019-2020 Town of Essex Budget in the amount of \$23,559 for the Finance Department as recommended and approved by the Board of Finance.
2. To consent and approve a supplemental appropriation to the 2019-2020 Town of Essex Budget in the amount of \$41,685 for the Town Clerk Department as recommended and approved by the Board of Finance.
3. To consent and approve a supplemental appropriation to the 2019-2020 Town of Essex Budget in the amount of \$22,586 for the Police Services Department recommended and approved by the Board of Finance.
4. To consent and approve a supplemental appropriation to the 2019-2020 Town of Essex Budget in the amount of \$61,070 for Fringe Benefits – Medical & Dental Insurance recommended and approved by the Board of Finance.
