### RESOLUTION

I, Joel Marzi Town Clerk of the Town of Essex, a municipality organized and existing under the laws of the State of Connecticut, hereby certify that the following is a true copy of the resolution adopted at the Regular Monthly Meeting held on September 22, 2021:

The Board of Selectmen hereby adopts the following Resolution for the acknowledgement of the abandonment of a portion of Evans Lane as a public highway, which abandoned portion is shown and designated as "Area Abandoned By the Town of Essex As A Public Highway Per Board of Selectmen" on a map entitled "Property Survey For Settlement Purposes Evans Lane on Land of The Trustee of the M&L 2012 Revocable Trust Agreement dated Aug. 3, 2012 15 Evans Lane, (A/K/A 12 Evans Lane) Essex, Connecticut Date: July 27, 2021 Scale: 1" = 20" prepared by Annino Survey, LLC, which map is to be filed in the Essex Town Clerk's office, and which abandoned portion is bounded and described as follows:

Beginning at a point on land designated "Public Right of Way known as Evans Lane", which point is the northwesterly corner of said Public Right of Way Known As Evans Lane, marked by a drill hole/iron pin set in a stone wall, all as shown on said map; proceed thence S 63°15'47" W along land now or formerly of Stasia J. Penkofflidbeck and Glenn J. Penkofflidbeck, being two separate lots as shown on said map, a distance of 120.52 feet to a point on remaining land of; proceed thence in a general southeasterly direction along other land of the Trustee of the M&L 2012 Revocable Trust Agreement dated Aug. 3, 2012, a distance of 49 feet, more or less, to a point of the abandoned public highway to the corner of the "Town Maintained" property on a "sketch map" prepared by Graham Pelton dated July 10, 1951, (see Note 2A of this map); proceed thence easterly along other land of the Trustee, being the "approximate edge of right of way" shown on said 1951 Toppin map, a distance of 374 feet, more or less to a point on the easterly line of the said Trustee's land which point is marked by a pin found in a concrete monument; proceed thence N 14°11'07" E along the easterly line of the Trustee's land, as shown on this map, a distance of 15.29 feet to a point; proceed thence S 68°76'29" W, along the Public Right of Way known as Evans Lane, as shown on this map, a distance of 90.86 feet to a point; proceed thence S 65°41'53" W, along said Public Right of Way known as Evans Lane, as shown on this map, a distance of 118.28 feet to a point; proceed thence S 62°44'07" W, along the Public Right of Way known as Evans Lane, as shown on this map, a distance of 32.93 feet to a point marked by a drill hole/iron pin set; proceed thence N 74° 49' 51" W along the Public Right of Way known as Evans Lane, as shown on this map, a distance of 44.44 feet to the point and place of beginning.
