6. NEW BUSINESS

a. Viney Hill Brook Park Conservation Commission Meeting Update

R Russo reported that the beavers residing at Viney Hill Brook Park Preserve are blocking up the outlet pipes within the ponds at Viney Hill Brook Preserve. Tim LaChance, Park and Rec Department and the Essex Public Works Department have been going out to the site and working to keep the pipes clear and monitor the water level. R Russo and M Barnes completed and submitted an application to the Inland Wetlands and Watercourse Commission for the installation of an outlet

pipe in Wollock's Pond that will run underwater and the pipe ending that will protrude from the end of the pond will be fenced, obstructing the beavers entry to the pipe, which will allow the water to remain at level. The cost of the installation of the pond leveler is \$2,200 and it will be installed by Beaver Solutions, LLC. R Russo stated that the installation will be complete by early spring 2017.

7. Commission Overview

V Willetts commented on the condition of the fields and asked about the upgrade of the mounds, the installation of clay and the erection of a fence to prohibit the balls from infiltrating the property of the adjoining neighbors. M Barnes stated that J. Kuzaro will upgrade and maintain the fields. V Willetts stated that the fence along the perimeter is curving and M Barnes will contact Atlas Fencing and ask them to look into the repair.

R Russo stated that in the past, behind home plate there were two, raised warm-up mounds for each team. M Barnes will look into the installation of the raised warm-up mounds.

A Mosa stated that there was a consensus to send a letter of appreciation to Jim Rawn, Tom Clerkin and Ed Burleson. M Barnes will look into this.
