#### 8. <u>Correspondence</u>

An inspection report of harbor buoys and quote for maintenance received from Brewer Dauntless Shipyard & Marina was reviewed and discussed. The quote that Cy Libby received from Dor-Mor, Inc. for pyramid anchors and shackles was also discussed. Action on both was tabled to the next meeting with three points to decide: (1) maintenance on the tackle; (2) consider buying new buoys and which ones to buy; and (3) the Dor-Mor anchor proposal.

Cy Libby noted that he picked up four moorings at Pettipaug that were left there after everything was closed. He has identified the permit holders of those moorings and will notify them of the removal by letter.

Joe also raised a concern with regard to the use of audible anti-bird devices. This will be discussed as part of the Harbor Management Plan update.

Jeff Going noted that he got in touch with Hydro Data, Inc. and received a quote from them to perform a hydrographic survey of North Cove and the channel. The quote was reviewed and discussed. Action on this was tabled to the next meeting.
