Hooker and Holcomb Update

Kathryn ("Kate") Pizzi, Investment Advisory Consultant, Hooker & Holcombe, introduced herself and provided an overview of her background.

Art Meizner gave everyone copies of an Investment Advisory Weekly Market Review produced by Hooker & Holcombe. Kelly Sterner will provide Art with everyone's email addresses so they can receive this on a weekly basis. He also shared a Wall Street Journal article regarding the Brexit Impact to U.S. Growth in 2016, which has not had a big impact.

He then presented the 2016 Second Quarter Review for the Town of Essex Retirement and Merit Service Plans, which included portfolio values, asset allocations and individual fund performance. He recommended some fund changes outlined on pages 13 thru 16 of the Review. No vote was required to make these changes.

Also included in his review was a Snapshot Report which everyone found to be helpful.

Kelly Sterner asked about timing for the annual contribution. This will be discussed at the October meeting and Kelly will seek Art's input prior to that meeting.

Art and Kate left the meeting at this point and the meeting proceeded in accordance with its other agenda items.
