Norman agreed that the Board of Finance should wait to vote on the budget amount to send to the Town Meeting although, there may not be any more news then what we have today. Kelly will show the various scenarios (should the whole state revenue loss become fact or just partial) on a

handout and get it out to the Board of Finance prior to the next meeting on April 21st.
