## Resolution – Authorizing the First Selectman to Accept OPM Grant Funds

#### **Budget Meeting**

Land Use - Mr. Needleman reported the land use reorganization was an overall increase of \$18,383. Tax Collector – there was discussion that both the Tax Collector and the Town Clerk are elected officials and should be paid the same. The Selectmen agreed that the Tax Collector should be brought up to the same pay rate as the Town Clerk.

Probate Court – No information received yet, so it was kept flat.

Fringe Benefits - No information on health insurance numbers yet, but the numbers will be adjusted for the Board of Finance when the information is acquired.

There was discussion regarding the Police Accountability Act (Public Act 20-1) that states officers are required to wear body cams. The body cams will be purchased with a special appropriation.

**Motion** was made by Norman Needleman to approve and recommend to the Board of Finance a Board of Selectmen's Budget request for Fiscal Year 2021 – 2022 in the amount of \$8,843,013 which represents an increase of 2.44% over the current fiscal year. Bruce Glowac seconded the motion. All in favor.

The Selectmen strongly recommended keeping taxes as low as possible this year, especially due to the pandemic.

Norman thanked the new Finance Director Tracey Celentano and Kelly Sterner for their hard work on the budget, and all Town Hall employees who have worked so hard this year in keeping the Town going during the Pandemic.
