Job Descriptions

Motion was made by Norman Needleman to approve the Harbor Commission Recording Secretary job description. Stacia Libby seconded the motion. All in favor.

The Selectmen discussed that effective immediately, recording secretaries shall receive a minimum of two (2) hours pay at the applicable rate for attending and working the regularly scheduled board or commission meetings or special meetings, provided that the time worked is not contiguous to his/her regularly scheduled hours. The Selectmen further agreed that if meetings are cancelled at the last minute on the day of the meeting due to lack of a quorum or other extenuating circumstances, that the recording secretary shall still receive a minimum of two (2) hours pay.

American Rescue Plan Funds (ARPA) None

American Rescue Plan Funds (ARPA) – Employee/Volunteer Appreciation

Security Cameras

Norman discussed quotes that were received for installation of security cameras in Town parks. This was tabled until next meeting.

Rumble Strips

The Town received a letter from the Department of Transportation regarding their plans to resurface Route 153 from Westbrook to Essex that would also include installation of centerline rumble strips (CLRS). The letter from DOT requires a signature that the Town concurs with the installation. The Selectmen, at this time, are not going to vote on whether to sign this today and tabled this to be discussed further at the next Selectmen meeting.

Motion was made by Bruce Glowac to adjourn the meeting at 6:02 p.m. Norman Needleman seconded the motion. All in favor.
