## 4. Public Hearings

**a.** <u>Cease and Correct Show Cause Hearing</u> **55 Pond Meadow Road, Ivoryton.** Removal of trees and vegetation within the 100-foot upland review area of a wetlands without a permit.

C Duques spoke to the commission, giving them a brief summary of the work that was done without a permit. She said there was clearing of understory brush and removal of 1 pine tree within the upland review area. She had left her card at the door and the property owner contact her and her and R Doane went out to the property. The owner was very understanding and cooperative and did not know that they needed a permit. The wetlands have been flagged since they were at the property. They do not wish to do any additional work to the property.

Travis Parker and Michelle Annicelli of 55 Pond Meadow Road spoke to the commission. They said that they had cut limbs and brush not know that there was an upland review area. They were trying to gain access to their well that they have been having trouble with. They explained that the invasives such as bittersweet were actually killing the trees along the wetland. They stressed that they are both responsible citizens and have had no other issues.

M Furgueson spoke, saying that over 50% of applications that the commission sees are after the fact. They have done a lot of work publicizing the wetlands regulations in Town so that people have a better understanding. The upland review area and the regulations have been in place for a long time. He explained that the wetlands commission has been quite accommodating and understanding of people's ownership of land and their ability to use their land. He explained that there is nothing wrong with these activities but there is a process for approval in the Town that must be followed. Minimal activity often allows for administrative approval. Last month, fees were increased in hopes that people would follow the rules and regulations, but we do have an option to wave those fees.

M Furgueson asked S Rutkowska how she suggests that they proceed. She replied that the cease and desist could be upheld, modified, or if terms of the cease and desist were satisfied the cease and desist would no longer be in effect.

#### 6. Receipt of Applications/New Business

a. <u>IWWC Application No. 23-02</u> River Road, Essex- Proposal to construct a pedestrian bridge over the Falls River and associated sidewalk along River Road located within 100 feet of a wetlands. *Applicant/Owner: Town of Essex* 

Alternate member N. Brennan-Rowe recused herself from this project. Alternate member C Field was seated for this application.

R Doane, Town Engineer, was present to talk about the project. He explained the Town is proposing to construct a sidewalk starting adjacent to 5 River Road running along the eastern side of River Road to Heritage Cove. There will be 3,400 square feet of sidewalk with a pedestrian bridge on the downstream side of the bridge extending over Falls River. There will be a retaining wall of precast concrete blocks along the wetlands within the 100 foot upland review area after the bridge. The sidewalk will be mostly monolithic style which includes a curb as part of the sidewalk.

The existing vehicular bridge is slated to be replaced in the next couple of years. The original plan was the widen the existing bridge and incorporate the sidewalk. They were not able to get the grant to replace the bridge but have a STEAP grant for \$600k for this particular project (which includes the sidewalks and associated drainage, i.e. catch basins, etc).
