- Mr. Meizner and Mr. Metzger then reviewed the portfolio changes, fund performance reports, OPEB Trust report, and OPEB Trust recommendations The T Rowe Price Growth Fund is being put on the "Watch List".
- The structure of the OPEB Trust was discussed. The equity portion of the
 portfolio is sufficiently diversified as the funds are indexed. Art would like to
 increase the diversification of the bonds and is seeking dedicated time at the
 next portfolio review meeting to discuss recommended changes.
- **b.** Hooker & Holcombe Knowledge Center program

There was general discussion about the knowledge center and what could potentially be included. Brenda from Hooker & Holcombe will reach out to Tracey and implement this program to help educate employees on retirement. A remote training for employees will be developed for the upcoming year.
