New Business:

a. First Quarter 2021 Portfolio Review – Roger Metzger & Art Meizner, Hooker & Holcombe

Roger Metzger and Art Meizner presented the 2021 First Quarter Review. Before starting the review Mr. Meizner introduced the "H&H Knowledge Center", an opt-in informational program for employees to better understand the investment markets. The Knowledge Center offers articles regarding retirement tips and trends, a weekly market email, and a quarterly webinar. Peter Decker suggested that the Board table the decision to share this information with employees until next month's meeting when more board members are in attendance.

Mr. Metzger and Mr. Meizner proceeded with their presentation. They shared the following market thoughts: the bond market yield spike, global equity fund flows, huge cash position on sidelines, Covid issues not affecting markets, the significant fiscal monetary stimulus and long-term portfolios.

H & H will continue to monitor inflation.

Mr. Meizner then examined asset allocations and returns, S & P 500 returns and valuation by sector, global equity market returns, international valuations, treasury yield graph, portfolio overviews, fund performance reports, and OPEB Trust report.

Mr. Meizner made the following portfolio recommendations:

- Sell Principal Equity Income Funs, Vanguard Interm-Term Bond Index Adm
- Increase Schwab Fundamental US Large Company Idx, calamos Market Neutral
 Income A
- Reduce Western Asset Core Bond FI, Fidelity Total Bond Fund, Metropolitan
 West Unconstrained Bd

All portfolio recommendations were approved by the Board.
