# Minutes October 15, 2019 – Zoning Board of Appeals

## 1. PUBLIC HEARINGS

 <u>Application No. 19-25</u> on behalf of Mallory Ortiz, 14 Chestnut Street, Ivoryton, CT, Assessor's Map 40, Lot 33, VR District, requesting variances to sections 40D, 40I.1, 40Q and 60B of the zoning regulations to locate an 8' x 12' above-ground pool deck to a point 15 feet from the rear property line where 20 feet is required. (Decision to be made by October 22<sup>nd</sup>)

Mallory Ortiz who presented on behalf of this application stated that she would like to build an 8' x 12' deck to the rear of her inground pool. The proposed deck falls within the setback. M Ortiz stated that the neighbors are in favor of this proposal.

M Ortiz stated that the hardship is partly due to the topography of the land and due to the location of the current existing shed.

W. T Furgueson asked if anyone wished to speak in favor or in opposition to this proposal.

There was no public comment.
